## Fact File 1984-88 Overview

This brief overview is provided to give the reader a synopsis of the major trends in each section of the **Fact File**. It is not intended as a replacement for the tables themselves, and does not highlight every table. Readers are encouraged to use this as a guide or overview, but are referred to the tables themselves for specific information. This five year period has been one of growth and change. This is evident in every section of the **Fact File**. Trends and patterns are highlighted below.

### **Section 1: Enrollment Trends**

- \* Since 1984, total headcount enrollment in the Autumn term has increased by 2,373, or 19.2% (see Table 1.1). The growth that has been experienced over this period has provided a solid foundation for the planned growth in future years.
- \* Contributing to the overall growth in headcount enrollment was the increase of the undergraduate day programs by 1,452 students, or 34.8%. Growth occurred in almost every program (see Table 1.1).
- \* Undergraduate evening program enrollment increased by 276, or 9.3%. This was contributed to most strongly by SNL, which experienced a 94.3% increase in enrollment during the five year period (see Table 1.5).
- \* Graduate school enrollments increased by 653 students, or 17.1% during the period. Since 1984, the greatest increases in *number* of students were experienced by the Graduate School of Business (356 students, or 15.2%) and LA&S (179 students, or 14.4%). There were also large *percentage* increases in the Theatre School (61 students, or 55%) and Education (31 students, or 21.7%).
- \* Since 1984, Law school enrollments declined by 8.8% or 99 students, although the 1988 Autumn enrollment increased by 56 students, or 5.8% from 1987.

### **Section 2: Demographic Characteristics of Students**

- \* Across the University, the percentage of minority students has increased from 18.6% in 1984 to 21.7% in 1988. There have been increases in the numbers of both minority and white students during the five year period. The number of minority students increased by 39.1% and the number of white students increased by 14.8% (see Table 2.1).
- \* Since 1984, the number of undergraduate minority students has increased by 648 or 37.4%. During this same time, the number of white students increased by 1,171, or 20.7% (see Table 2.1).
- \* The percentage of minority students enrolled in graduate programs has grown from 12.5% in 1984 to 16.2% in 1988. The number of minority students increased by 247, or 51.7% and the number of white students increased by 406, or 12.1% during the period.
- \* In 1984 the percentage of minority students in the Law School was 8.1%, in 1988 it is 8.8%. Because of the declining enrollments in law, both the number of minority and white students has declined. Minority enrollments have declined by 1.1% (1 student), while white enrollments have declined by 9.5% (98 students).

- \* There have been increases in the percentage of women students at all levels since 1984. The percentage of women has increased by 2.7 percentage points at the undergraduate level, 1.4 percentage points at the graduate level, and 3.1 percentage points at the professional level (see Table 2.3).
- \* Overall, DePaul has retained the diversity for which it strives while at the same time increasing enrollments and expanding student markets.

### **Section 3: Admissions Profile of New Students**

#### **First-time freshmen**

- \* The size of the freshmen class has grown consistently over the past five years. Since 1984, the freshmen class has grown by 349 students, a 46.3% increase.
- \* The yield for new freshmen has trended downward since 1986. This is due to the expansion of markets and the increase in the applicant pool which has grown 73% over the period (see Table 3.1).
- \* There has been steady improvement in the ACT composite scores of new freshmen since 1984. Scores continue to be well above the national average (see Table 3.3).
- \* The percentage of out-of-state students in the new freshmen class has nearly tripled, from 7.6% in 1984 to 21.2% in 1988 (see Table 3.5).
- \* Taken together, the above indicates the increasing selectivity and competitiveness in freshmen admissions. These trends are likely to continue as DePaul remains committed to expanding its markets and maintaining and improving the quality and diversity of its student population.

#### **Transfers**

- \* Over the past five years, transfer enrollments have increased by 41%, or 327 students.
- \* For new transfers the acceptance rate declined from 84.6% in 1984 to 74.1% in 1988, but the yield increased from 67.2% to 84.7% during the same period (see Table 3.1).
- \* The demographic profile of new transfer students shows an increase in the percentage of older students in both the 24-29 and 30 and over groups since 1984 (see Table 3.10).
- \* Current planning calls for increasing selectivity in admissions for transfer students. In addition, OIPR will conduct studies concerning the performance of transfer students.

#### **Graduate and Professional**

- \* Since 1984, new graduate student enrollment increased by 5.2%, or 52 students, and new JD law student enrollment increased by 6.7%, or 21 students (see Tables 3.15 and 3.18).
- \* Enrollment trends among graduates show that the yield has been fluctuating over the 5 year period, but is down overall to 66.3% in 1988 from its high of 74.2% in 1984 (see Table 3.13).

- \* In the demographic profile of new graduate students, there has been an increase in the percentage of minority students when compared to 1984, but the percentage is down from its high in 1986 (see Table 3.15).
- \* Since 1984, Law School percentage of acceptances decreased from 60.2% to 48.2%. During the same time period, the yield increased from 26.3% to 34.3% (see Table 3.16).
- \* The academic indicators for incoming Law students have improved over the five year period and are above the national average. The improving academic quality and the decreased acceptances reflect recent efforts to improve the overall quality of the class (see Table 3.18).

#### **Section 4: Degree Recipients**

- \* Since 1984-85, the number of undergraduate degrees awarded has increased by 11.9%. It is expected that this will increase further as larger classes matriculate (See Table 4.1).
- \* There has been a steady increase (15.3% over the period) in the number of Master's degrees awarded since 1984. This increase was produced predominantly by growth in computer science and information systems (see Tables 4.1 and 4.3).

#### **Section 5: Student Financial Aid and University Finances**

- \* Over the period, total financial aid grew by 48.4%, led by a 66% increase in institutional funds (see Table 5.1).
- \* Total fund balance (net worth) growth (40.9%) has outpaced inflation (22.3%) during the period (see Table 5.2).
- \* The University consistently generated an operating surplus. The majority of excess funds were transferred to Plant and Endowment funds (see Table 5.3).

#### **Section 6: Faculty and Staff Statistics**

- \* The number of full-time faculty increased by 57, or 15.4% during the five-year period due to the number of new faculty hired for replacement and expansion (see Table 6.1).
- \* The percentage of tenured faculty in 1988-89 has declined from the previous year (see Table 6.2).
- \* The number of full-time professional staff has increased by 23.2% since 1984 (see Table 6.1).
- \* The number of full-time non-professional staff increased by 15.1% since 1984 (see Table 6.1).

#### **Section 7: Other University Statistics**

- \* Library collections have consistently expanded since 1984.
- \* The total number of grant applications and awards has increased throughout the period (see Table 7.2).

AUTUMN 1984 - AUTUMN 1988





AUTUMN 1988



### AUTUMN 1984 THROUGH AUTUMN 1988



AUTUMN 1988











AUTUMN 1988





AUTUMN 1988







AUTUMN 1988




