## Fact File 1985-89 Overview

This brief overview provides a synopsis of the major trends in each section of the Fact File. Readers are encouraged to use this as a guide or overview, but are referred to the tables themselves for specific information.

### **Section 1: Enrollment Trends**

- \* Since 1985, total headcount enrollment in the Autumn term has increased by 2,551 students, or 19.9% (see Table 1-1).
- \* Increases in undergraduate day enrollment contributed significantly to the overall increase in headcount during the five-year period. Since 1985, undergraduate day enrollment increased by 1,363 students, or 28.9%. This reflects University planning efforts to expand this population (see Table 1-1).
- \* Undergraduate evening program enrollment increased by 339, or 11.3%. This increase was contributed to most strongly by SNL, which more than doubled its enrollment during the five year period (Table 1-5).
- \* Graduate school enrollments increased by 843 students, or 20.8% from 1985 to 1989. Since 1985, the Graduate School of Business has expanded its enrollment by 438 students (18.2%), and Liberal Arts & Sciences graduate programs have grown by 286 students (20.9%).
- \* Enrollment in doctoral programs steadily increased during the five-year period (see Table 1-4).
- \* Law School enrollments during the period from 1985 to 1989 fluctuated. When compared to 1985, the Autumn 1989 enrollment (1,076) increased by less than one percent (6 students); however, compared to last Autumn, enrollment increased by 49 students, or 4.8%.

### **Section 2: Demographic Characteristics of Students**

- \* Across the University, the *percentage* of minority students remained stable during the five year period. The *numbers* of both minority and white students have increased since 1985. The number of minority students increased by 26.6%, and the number of white students increased by 16.5% (see Table 2-1).
- \* The stability in the percentage of minority enrollments and growth in the numbers of students University-wide is also evident in the undergraduate population. Since 1985, the number of minority undergraduates increased by 474, or 25.1%, and the number of white undergraduates increased by 1,140, or 19.8% (see Table 2-1).
- \* The *percentage* of minority students enrolled in graduate programs has grown from 12.1% in 1985 to 14.0% in 1989. The *number* of minority students increased by 196, or 40.0%, and the number of white students increased by 548, or 15.6% (see Table 2-1).
- \* The *percentage* of women enrolled in graduate and professional programs has increased since 1985, while the *percentage* of women enrolled as undergraduates has been stable. Traditionally, over half of the undergraduate population is female, while less than half of the graduate and professional population is female (see Table 2-3).
- \* The age distribution of the overall student population has changed steadily throughout the five-year period. The *percentage* of students under 24 declined by 3 percentage points, while the *percentage* of students in the 24-29 and 30-44 age categories increased by two and one percentage points, respectively (see Table 2-7).

### **Section 3: Admissions Profile of New Students**

#### **First-Time Freshmen**

- \* Since 1985, the freshmen class has grown by 23.6%, although Autumn 1989 enrollment declined by 6.0% from 1988 (see Table 3-1).
- \* Contributing to the decline of new freshmen was a stable applicant pool and a declining yield (see Table 3-1).
- \* There has been steady improvement in the academic profile of new freshmen since 1985. ACT composite scores, as well as high school grade point averages for entering freshmen (not including Bridge) have increased. ACT scores continue to be well above the national average (see Table 3-3).
- \* Since 1985, the percentage of freshmen enrolled in LA&S has increased to 46.1% from 41.6%, while the percentage of freshmen enrolled in Commerce has declined to 37.2% from 47.0%. The percentage of new freshmen enrolled in Theatre has also increased by 4.5 percentage points (see Table 3-5).

#### **Transfers**

- \* Transfer enrollment increased from 1985 to 1988, but declined in 1989. This reflects the University's enrollment planning objective to reduce the number of transfer students (see Table 3-10).
- \* The acceptance rate for new transfers has decreased over the period, indicating increasing selectivity (see Table 3-10).
- \* The academic quality of transfer students, as indicated by transfer grade point average, has remained stable throughout the five-year period (see Table 3-11).

#### **Graduate and Professional Students**

- \* Since 1985, new graduate student enrollment has grown by 262 students, or 26.5% (see Table 3-14).
- \* Enrollment trends for graduates show that the yield has fluctuated over the period, but increased to 69.5% in 1989 from 66.3% in 1988 (see Table 3-14).
- \* Since its low in 1987, enrollment in Law increased by 45 students, or 15.4% (see Table 3-17).
- \* The Law School percentage of acceptances decreased from 57.4% in 1985 to 40.0% in 1989. Yield has fluctuated between 28.5% and 34.3%, and is currently 31.6%. This is the result of a rapidly expanding applicant pool (see Table 3-17).
- \* The academic indicators for Law students, LSAT scores and undergraduate GPA, increased steadily over the five year period. LSAT scores remain above the national average (see Table 3-19).

#### **Section 4: Resident Student Statistics**

- \* The profile of Residence Halls (1987 to 1989) shows that the number of students living on-campus increased by 442, or 47.0% since 1987 (see Table 4-1).
- \* The percentage of residents who are LA&S students increased to 50.1% in 1989 from 44.0% in 1987, while the percentage of Music, Commerce, and Education students declined during that same period (see Table 4-1).
- \* Over half of entering full-time freshmen, and over twenty percent of entering full-time transfer students live in the residence halls (see Table 4-3)

#### **Section 5: Degree Recipients**

- \* The number of degrees awarded increased by 292, or 11.7% during the five-year period (see Table 5-1).
- \* Since 1984-85, the number of undergraduate degrees awarded increased by 19.7%. Contributing to this was a 36.3% increase in the number of Commerce graduates (see Table 5-2). The number of Master's degrees awarded also has increased by 123, or 12.9%.
- \* The number of JD-Law degrees awarded declined from 311 in 1984-85 to 245 in 1988-89 (See Table 5-1).

#### **Section 6: Student Financial Aid and University Finances**

- \* Over the period, total financial aid grew by 45.8%, led by a 54.8% increase in Institutional funds (see Table 6-1).
- \* Total fund balance (net worth) growth (46.3%) outpaced inflation (20.2%) during the period (see Table 6-2).
- \* The University consistently generated an operating surplus. The majority of excess funds were transferred to Plant and Endowment funds (see Table 5.3).

#### **Section 7: Faculty and Staff Statistics**

- \* The number of full-time faculty increased by 83, or 22.1% during the five-year period. This increase is the result of new faculty hired for replacement and expansion (see Table 7-1).
- \* The number of full-time professional staff has grown steadily from 332 in 1985 to 443 in 1989, an increase of 33.4% (see Table 7-1).
- \* The number of full-time non-professional staff increased by 17.6% during the five year period (see Table 7-1).

#### **Section 8: Other University Statistics**

- \* Library collections have consistently expanded in all categories since 1985 (see Table 8-1).
- \* The total number of grant applications and awards has increased. Although the dollars applied for in both the Agency funding and DePaul cost-share funding categories declined from last year, the dollars awarded increased (see Table 8-2).

AUTUMN 1985 - AUTUMN 1989



**AUTUMN 1985 AND AUTUMN 1989**



ACADEMIC YEAR



AUTUMN 1989



AUTUMN 1989













AUTUMN 1985 TO AUTUMN 1989




