LETTER TO THE UNIVERSITY COMMUNITY

University Colleagues,

It is with great pleasure that I present DePaul's 2015 enrollment summary. This annual report describes the university's enrollment profile and how it has changed over the years as we have pursued our ambitious enrollment goals.

DePaul's fall 2015 enrollment of 23,539 students surpassed not only the overall target, but also the individual targets for the undergraduate, graduate and law populations. And even with a slightly lower overall enrollment than last year, we generated a record level of tuition revenue. Taken together, these successes are critical to maintaining and enhancing our academic enterprise.

One of the most promising achievements this fall is in new student enrollment. The 6,415 new students eclipse the budget target by 4 percent, creating a multiple-year positive impact that positions us favorably to weather the inevitable market volatility we will encounter in upcoming enrollment cycles.

The diversity of our students also stands out. The 8,229 students of color represent the highest number ever at DePaul. Students of color comprise 38 percent of undergraduate students, 29 percent of graduate students and 25 percent of law students—all university records. While many institutions talk about improving diversity, we achieve it. It is an integral part of our enrollment strategy.

Moving forward, we'll face challenges. The marketplace is becoming ever more competitive. An increasing number of out-of-state institutions are intensifying their recruitment efforts in the Chicago area despite a declining number of high school graduates and graduate students in the region. While our success this year does not guarantee our success in the future, it does reaffirm that DePaul's brand still resonates strongly with students and families.

None of these enrollment outcomes would be possible without the dedication and effort of all who teach and work at DePaul. You continually deliver the high-quality education and world-class experience that differentiates DePaul from other institutions. Thank you for all that you do to ensure our enrollment success.

UNIVERSITY ENROLLMENT

DePaul remains the nation's largest Catholic university for the 18th consecutive year, with a total student enrollment of 23,539. This is comparable with last year, down only 260 students or 1.1 percent.


Undergraduate Enrollment – 15,961 students enrolled this fall, compared with 16,153 in 2014. Undergraduate enrollment accounts for 68 percent of total enrollment in 2015, up from 65 percent in 2011.

Graduate Enrollment – 6,800 students enrolled this fall, compared with 6,844 in 2014, accounting for 29 percent of university enrollment.

Law Enrollment – 778 students enrolled this fall, down 3 percent from 2014. Law enrollment accounts for 3 percent of university enrollment.

Students registered for a total of 293,979 credit hours in fall 2015. Eighty percent of these credit hours were generated by undergraduate courses and 20 percent by graduate and law courses.

UNDERGRADUATE ENROLLMENT

DePaul enrolled 15,961 undergraduates this fall, compared with 16,153 in 2014. Despite the overall decline, CDM undergraduate enrollment increased 14 percent, with smaller increases for CSH and Theatre (1 percent and 2 percent, respectively). Enrollment declined in the remaining colleges. Since 2011, BUS, with the largest share of undergraduate enrollment, remained relatively steady. Enrollment in CSH and CDM, the next largest colleges for undergraduate enrollment, increased by 26 percent and 46 percent, respectively, in that time.


Undergraduate Enrollment by College

FRESHMAN ENROLLMENT

DePaul welcomed a class of 2,519 new freshmen in fall 2015, a slight decrease from last year's class of 2,544 students. Enrollment increased by 28 percent in CDM and 23 percent in Music. These increases offset double-digit declines in COE and CMN. BUS continues to enroll the largest proportion of freshmen at 27 percent.

By Academic Profile

The freshman class is strong on all measures of academic preparedness.

- » The average high school GPA—the best predictor of academic success at DePaul—is 3.56, the same as 2014 and down slightly from a record 3.65 in 2013.
- » The average ACT composite score of all DePaul freshmen is 25.2,* comparable with last year's ACT composite of 25.4. The middle 50 percent of the class scored between 22 and 28. Nationally, the average ACT composite score is 21.0.
- » About 9 percent of the freshman class, or 238 students, enrolled in the university's Honors Program in fall 2015. The average ACT composite for freshmen in the Honors Program is 29.1.
- » Freshmen came from more than 1,000 high schools, with the top 20 high schools accounting for 17 percent of the class.
- » Freshmen enrolled in nearly 100 different majors.

Freshman Enrollment by College



TRANSFER ENROLLMENT

Enrolling in fall 2015 are 1,619 new undergraduate transfer students, a 2 percent increase from 2014, following a three-year decline in transfer enrollment. The four largest colleges for transfer enrollment—BUS, LAS, CSH and CDM—increased over 2014 and together enroll 77 percent of transfers. Sixty-one percent of transfers come from community colleges. Forty-two percent of this fall's new transfers enter DePaul with sophomore status, and 32 percent enter with junior status.

Transfer students are an important component of DePaul's enrollment profile. Throughout the 2014-15 fiscal year, DePaul enrolled a total of 2,472 transfer students and 2,587 freshmen. This fall, transfers account for 39 percent of new degree-seeking undergraduates, compared with 38 percent in 2014.




FRESHMAN AND TRANSFER DEMOGRAPHICS

Freshmen

By Gender

- » Less than half of all new freshmen are male (44 percent) in 2015, compared with 43 percent in 2011.
- » Enrollment in CSH, LAS, CMN, COE and Theatre is more than 65 percent female.

By Geography

- » 41 percent come from suburban Chicago or elsewhere in Illinois, 41 percent from out of state or out of country, and 18 percent from the city of Chicago.
- » California is the top state for freshmen (other than Illinois), sending 143 new freshmen this fall. Rounding out the top five are Michigan, Ohio, Wisconsin and Indiana.
- » The 1,021 out-of-state freshmen come from over 775 high schools throughout the nation.

First-Generation Freshmen

- » Enrolling this fall are 872 freshmen from families where neither parent has a bachelor's degree, up from 856 in 2014. First-generation students represent 35 percent of the freshman class.
- » A total of 45 percent of new freshmen in CSH are first-generation.
- » A total of 45 percent of this year's first-generation students come from suburban Chicago.

Transfers

By Gender

- » Over half of all new transfers are male (55 percent) in 2015, compared with 51 percent in 2011.
- » Enrollment in CSH, SNL, COE and CMN is more than 50 percent female.

By Geography

- » DePaul remains a top destination for transfer students in Illinois.
- » 61 percent of transfers are from Illinois community colleges.
- » 27 percent are from out-of-state institutions.
- » 6 percent are from Illinois private four-year institutions.
- » 4 percent are from Illinois public four-year universities.
- » 2 percent are from other types of institutions.

By Age

- » 71 percent of new transfers are under 24, 19 percent are 24-29 years of age, and 10 percent are 30 or older.
- » SNL enrolls 34 percent of all new transfer adults (24 and older) and 63 percent of those who are 30 years of age or older.

FRESHMAN ADMISSION TRENDS

DePaul received 19,628 freshman applications for fall 2015, a 2 percent decline from the record set in 2013, but a 17 percent increase from 2011. A total of 1,597 students applied through the test-optional pilot program.

- » CSH received 26 percent of the applications at 5,189, the most of any college.
- » Applications to CDM increased by 26 percent, with smaller increases for Theatre and BUS. CDM accounted for 12 percent of applications in 2015, compared with 10 percent in 2014.
- » Similar to the past two years, 39 percent of applications came from out of state. California, Michigan and Ohio provided the most out-of-state applications.

Freshman Applications, Admission and Enrollment Yield





TRANSFER ADMISSION TRENDS

Transfer applications increased this year to 5,182 after two years of decline. Applications increased in all colleges, with the exception of CMN, SNL, Music and Theatre. Applications to BUS and CSH accounted for 44 percent of all transfer applications.

Transfer Applications, Admission and Enrollment Yield




RETENTION AND GRADUATION RATES

Returning in fall 2015 for their sophomore year are 84 percent of the fall 2014 full-time freshmen, compared with 87 percent of the prior year's freshman class.

One of the most significant trends is the continued improvement in the four- and six-year graduation rates over the past eight years. This year, the four-year graduation rate for the 2011 freshman class was 59 percent.

Of the fall 2009 full-time freshmen, 73 percent had graduated from DePaul six years later, a university record and a 6 percentage-point increase from the 2005 class.

Freshman Retention and Graduation Rates




THE FOUR-YEAR GRADUATION RATE FOR FRESHMEN HAS INCREASED NEARLY 11 PERCENTAGE POINTS IN THE LAST SIX YEARS.

The transfer one-year retention rate captures the percentage of new transfer students from all terms of the prior year* who return for the fall term. Because the methods for calculating freshman and transfer retention rates are different, the rates should not be directly compared.

The transfer retention and graduation rates have been relatively stable over recent years. This fall, the one-year retention rate is 83 percent. Sixty percent of students who transferred to DePaul during the 2011-12 academic year graduated within four years. The six-year graduation rate for students who transferred during the 2009-10 academic year is 67 percent.


Graduate Enrollment

In fall 2015, a total of 6,800 graduate students enrolled (excluding Law). Although overall graduate enrollment is down 44 students from 6,844 students in 2014, enrollment in CDM (the largest graduate college) and COE both increased in 2015 (by 7 percent and 3 percent, respectively). A total of 93 percent of all graduate students are master's degree students, 5 percent are doctoral students, and 2 percent are in certificate programs or non-degree seeking.

- » 65 percent are enrolled full time, taking eight or more credit hours per quarter, up from 59 percent in 2011. Full-time graduate enrollment varies by college. As in 2014, the colleges with primarily full-time graduate enrollment include Theatre (100 percent), CMN (85 percent), CSH (75 percent), COE (70 percent) and KGSB (66 percent). The largest proportion of part-time graduate enrollment is in SNL (81 percent).
- » 29 percent are students of color (1,971 students), comparable with last year.
- » 13 percent are under 24 years of age, comparable with last year.

Graduate and Law Enrollment by College




Law Enrollment

A total of 778 students enrolled in the College of Law this fall, a decline of 3 percent from 2014. Most law students are enrolled in the JD day program—78 percent—with 19 percent in the evening program and 3 percent in the LLM program.

- » 40 percent were originally from out of state or international locations (45 percent in 2014).
- » 58 percent are female (57 percent in 2014).
- » 26 percent are under 24 years of age (29 percent in 2014).
- » 25 percent are students of color (23 percent in 2014).

NEW GRADUATE ENROLLMENT

New Master's Enrollment

The 1,688 new master's students enrolled in fall 2015 are 11 students more than 2014.

- » 54 percent are female (56 percent in 2014).
- » 45 percent are between ages 24 and 29, and 29 percent are under age 24 (48 percent and 31 percent, respectively, in 2014).
- » 29 percent are students of color (26 percent in 2014).
- » 16 percent are international students on F1 and J1 visas (17 percent in 2014); 45 percent of international students enrolled in KGSB and 43 percent in CDM.


The new master's students come from a wide range of locations:

- » 41 percent are from the city of Chicago (39 percent in 2014).
- » 35 percent are from suburban locations and elsewhere in Illinois (37 percent in 2014).
- » 23 percent are from out of state (23 percent in 2014).

New Master's Enrollment by College




New Doctoral Enrollment

A record number of 78 new doctoral students enrolled this fall, compared with 68 in 2014. Fifty percent of these students were in CSH (including 24 new students in the nursing doctoral program), 26 percent in COE, 18 percent in KGSB and 6 percent in LAS.

- » 65 percent are women (63 percent in 2014).
- » 51 percent come from the city of Chicago (44 percent in 2014).
- » 24 percent are students of color (21 percent in 2014).

New Law Enrollment

The College of Law welcomed 278 new law students this fall, compared with 264 in 2014. Of the new law students, 208 are enrolled in the day program, 63 in the evening program and 7 in the master of laws (LLM) program.

- » 49 percent are under 24 years of age (50 percent in 2014).
- » 60 percent are women (61 percent in 2014).
- » 38 percent are from out of state or international locations, 38 percent from suburban Chicago and other Illinois locations, and 24 percent from the city of Chicago (44 percent, 30 percent and 25 percent, respectively, in 2014).
- » 23 percent are students of color (28 percent in 2014).



CREDIT HOUR DISTRIBUTION

The Lincoln Park and Loop campuses generated 44 percent and 42 percent of fall credit hours, comparable with 2014. Off-campus locations (overseas and study abroad locations, Cinespace and Rosalind Franklin University of Medicine and Science) generated 9,235 credit hours (10,009 in 2014). Online course credit hours increased 14 percent this fall to 28,655 and are up 49 percent since 2011. Online credit hours account for 10 percent of all fall credit hours, compared with 9 percent in 2014.

A total of 5,560 students registered for at least one online course (3,884 undergraduate and 1,676 graduate students). This is a 13 percent increase from 4,906 students in 2014. Of these students, 1,786 students are enrolled exclusively online and not enrolled in campus-based courses (716 undergraduates and 1,070 graduate students). Seventy-two percent of these students are from the Chicago metropolitan area. CSH and BUS have the greatest increase in the number of students taking at least one online course, 42 percent and 25 percent, respectively.



DIVERSITY

DePaul enrolled 8,229 students of color in 2015, compared with 8,139 in 2014. Students of color account for 35 percent of total enrollment, 38 percent of undergraduate enrollment, 29 percent of graduate enrollment and 25 percent of law enrollment.

A total of 755 students report themselves as multiracial/non-Hispanic students in 2015, compared with 795 in 2014. A total of 78 percent of these students are undergraduates.

International Students on F1 and J1 Visas

In total, 1,535 students have international student status (on F1 and J1 visas), compared with 1,335 in 2014 and 1,069 students in 2011 (a 44 percent increase). This year, about one-third of international students are undergraduates, and two-thirds are graduate and law students. International students represent 7 percent of total university enrollment.

International Undergraduate Enrollment Trends

- » International undergraduate enrollment has been growing annually, from 270 in 2011 to 528 in 2015. Almost half of these international students enrolled in BUS (49 percent).
- » International undergraduates come from more than 75 countries, with China the largest source and accounting for almost one-third of international undergraduate students, followed by Nigeria, Saudi Arabia, Malaysia and South Korea.
- » 59 percent are men.


International Graduate and Law Enrollment Trends

- » A total of 1,007 international graduate and law students enrolled in 2015, an increase from 858 in 2014. The largest proportion of students enrolled in CDM and KGSB (41 percent and 40 percent, respectively).
- » Students come from over 60 countries, with more than one-third from China, followed by Saudi Arabia and India.
- » 55 percent are women.

NATIONAL COMPARISONS

DePaul is the largest private, not-for-profit university in the Midwest and the 13th largest private institution nationally. DePaul has been the largest Catholic university in the nation for 18 consecutive years, having exceeded St. John's University in total enrollment in 1998. DePaul enrolled 11 percent of the enrollment at the 15 largest Catholic institutions in 2015.

Since 2006, enrollment at the largest Catholic institutions increased by 6 percent to 213,144 students, an increase of 12,076 students. From 2011 to 2015, enrollment at these institutions remained largely unchanged, decreasing by 748 students. From 2014 to 2015, total enrollment was flat or in decline at six of the 15 largest schools.
